Discussion and possible action regarding approval of a Resolution and application for the Business Improvement Grant (BIG) by Prime-Time Restoration located at 11495 Toepperwein Road, Live Oak, Texas for the approval authorizing a reimbursement payment directly to the owner in accordance with the BIG requirements - Mrs. D. Lowder

Ms. Lowder provided the following during the Staff presentation:

- Heath Pipes, President/owner of Prime-Time Restoration (PTR) has applied for the Business Improvement Grant (BIG) to assist with building façade, painting, roofing, and parking lot improvements at his commercial property located at 11495 Toepperwein Road, Live Oak, Texas 78233. The improvements will not only repair the damage to Building 2 but will provide a cohesive look to the buildings.
- Scope of Work
- Contractor information and total amount of the project \$51,967.48
- Applicant's obligations in accordance with the Performance Agreement within the 180 days
- City's obligations are in accordance with the Performance Agreement within the 30 days of being in receipt of all inspections, reports, paid receipts, and Reimbursement Request letter.
- The City will make a final on-site inspection by the City Building Official to ensure safety and quality improvements upon completion.
- Staff committed to presenting the project to the Board at a future meeting prior to issuing any grant payments.

It was the consensus of the Board that the scoring sheet provided was useful and assisted the Board in making the final decision.

City Manager Garfaoui added that the project was derived as an incentive for property owners to be attracted to Live Oak and retain. Property values will increase because of the beautification and not decrease, which is the LOEDC's purpose of the beautification grant.

Board President Dennis asked for updates for each of the BIG applicants throughout the progress of the updates.

A motion was made by Council Director Tullgren to approve Resolution 2025-05 authorizing a reimbursement pay of \$50,000 in connection with the Business Improvement Grant (BIG) to Prime Time Restoration with an effective date; seconded by Citizen Director Green.
