#### 6. NEW BUSINESS

A. Presentation, update, and possible discussion regarding the City Gateway Monuments located at RBFCU Headquarters and the TXDOT Triangle-Pat Booker (SH 218) – Mrs. D. Lowder

Mrs. Lowder provided a comprehensive presentation regarding the timeline and progress of the RBFCU & The Pat Booker Triangle monument projects:

- The RBFCU gateway monument was approved through an Easement Agreement between the City of Live Oak and RBFCU for the purpose of signage entering the City on January 11, 2023 under Resolution 2073 approved on December 12, 2023.
- The construction of the monument would include signage for RBFCU and signage for promoting Live Oak, mature trees, and landscaping within the property's detention/retention area.
- A fence shall be re-located inside and around the new monument for access to the monument for maintenance, repairs, and landscaping care.
- The LOEDC Board approved \$200,000
   Construction began October 2024 by Abelar Inc

# Pat Booker Triangle:

- This project included a Gateway Monument Agreement between the State of Texas and City of Live Oak approved on September 4, 2024, and funding under Ordinance #1658.
- TXDOT provided landscaping and pavers surrounding the entire space prior to commencing construction.
- 15 ft. Freestanding monument that will include the City's swish with leaf on the sides, Topper is a 4- sided City seal, and City's name cutouts run along the sides of the structure. (Foundation is rectangle instead of round and has been built up to be higher)
- The monument will have LED backlighting on the sides and LED lights illuminating from the top behind the four-sided cut-out of the City's Seal with a protective/heat resistant velum so as not to impair drivers.
- The LOEDC Board approved \$200,000.
- Construction began May 2025 by Abelar Inc.
- **Remaining:** 50% of the sign limestone veneer façade, attach metal decorative logo pieces, install LED back and up-lighting, and replace TXDOT landscaping damaged by construction.
- Receive TXDOT approval and move forward with a maintenance agreement.
